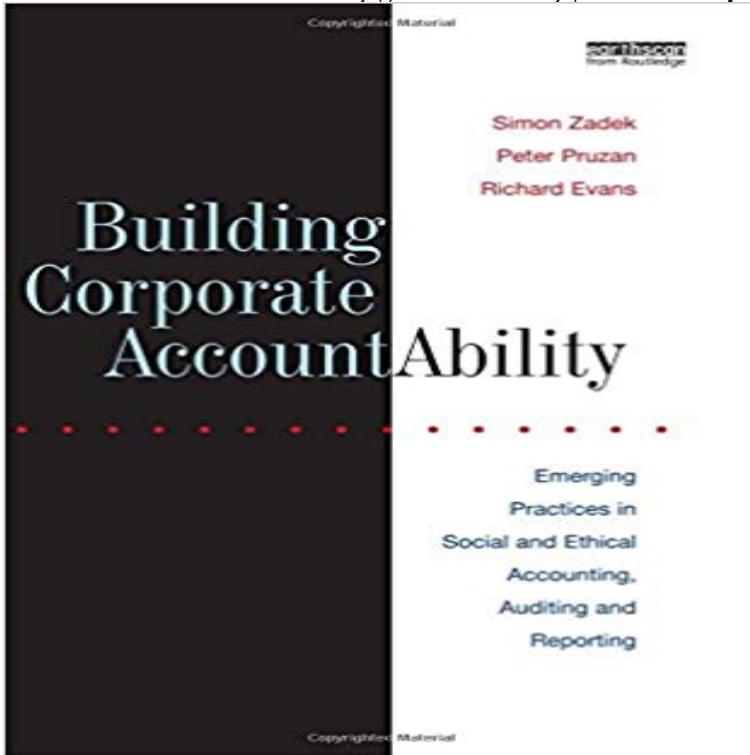


# Building Corporate Accountability: Emerging Practices in Social and Ethical Accounting, Auditing and Reporting
